

FILING FEES

About Filing Fees

- Filing fees in bankruptcy cases are prescribed by the Judicial Conference of the United States. The amount of the fee varies depending on the type of pleading being filed or the nature of the service being requested from the Office of the Clerk. A complete list of the current filing fees can be viewed and printed by going to the court's internet site (www.flnb.uscourts.gov) and clicking on the "Court Resources" tab.
- Payment of filing fees online is a service of Pay.Gov which is a service for making secure electronic payments to agencies of the federal government. The U.S. Bankruptcy Court for the Northern District of Florida maintains no control over transactions with Pay.Gov and does not retain credit card information entered into the system. 
- Failure to pay filing fees on the day incurred may result in the document being stricken from the record.

Paying Fees As Pleadings Are Filed

- Most documents and pleadings filed with the court do not require the payment of a filing fee and no fee is associated with the event in ECF. Those events which do require a fee will notify the user of the fee amount during the filing process by displaying a screen indicating the fee amount prior to completing filing process. This is an information screen only. Click "**Next**" to continue.
- After the filing process is complete, a window will open and display any filing fees which are due. If you click on the "**Pay Now**" button a new screen will appear prompting you to enter credit card information for payment of filing fees. A receipt will be displayed after submitting your online payment.
- If you have additional pleadings to file, you can click on "**Continue Filing**" and continue to open cases or file additional pleadings. The ECF system will keep track of any additional fees incurred and will re-open the pop-up window after the completion of each filing process. This will continue until such time as the fees are paid online.

Paying Fees through the Utilities Menu
