### **QC Cues**

## Quality Control Reminders from the Case Administrators

- ➤ Notice of Appearance or Request for Notice: When electronically filing a Notice of Appearance or a Request for Notice, please be sure to add the address to where notices should be sent if notice is to be sent to an address other than or in addition to the address of record for the person electronically filing the Notice or Request. Failure to input this information will result in the recipient not being added to the official mailing matrix.
- ➤ Box 4 Your Employer Identification Number: When completing bankruptcy paperwork, the debtor's employer's Employer Identification Number ("EIN") should <u>not</u> be provided in Box 4 of an individual debtor's Voluntary Petition unless the debtor is self-employed and the EIN belongs to the debtor (i.e., "<u>Your</u> Employer Identification Number, if any"). Courts across the nation are seeing an increase in debtors' employer's EINs being entered into this field which is causing many cases to be reported as "repeat filers" when they actually are not. A debtor incorrectly determined to be a repeat filer may encounter difficulties with the automatic stay and at the time of discharge.



# **An Unexpected View**

When attending hearings by video, please be mindful of the view you share with your colleagues. Use the settings in your program to blur the background or participate from a location appropriate to the circumstances and with an environment that would not be distracting to the other participants (e.g., a quiet, well-lit room with a neutral background). To maximize your non-verbal communications, position the camera at head height and zoom in or out so that only your head, torso, and arms are in the camera view.

# Ordering Transcripts & Digital Court Recordings

The <u>Ordering Transcripts & Recordings</u> page of our website has been updated to include instructions and links to Local Forms for ordering a transcript or a digital court recording ("DCR") and an alphabetized list of approved transcription service providers (the list order does not indicate the Court's preference). When submitting your order, you must provide all the information requested on the form and pay any applicable fee for us to timely process your request.

# **Coming Soon to FLNB**

**Negative Notice List**: An updated Negative Notice List will soon be posted to our website. This revision cycle includes a new negative notice legend specifically for fee applications. We will post an announcement on our website and send an email notification to let you know when the new list is available. All negative notice legends currently in use are available on the Local Forms page of our website in the "Local Forms (any chapter)" section.



**E-Orders**: We anticipate launching the new (to FLNB) E-Orders program this June to replace the current method of submitting proposed orders. As part of this new process, the Proposed Orders Guidelines will be revised to reflect new formatting requirements and will be published in advance of the launch to allow you sufficient time to modify your document templates. We will provide a training video on how to use the new program ahead of the "go live" date.

# **Bankruptcy Filings on the Rise**

The Administrative office of the U.S. Courts ("the AO") <u>reported</u> in January that total bankruptcy filings nationally rose 16.8% in 2023, with significant increases in both business and non-business bankruptcies. Locally in the Northern District of Florida, we saw an increase of 21% in bankruptcy case filings (business and non-business) - 10% of which were filed *pro* se - and a whopping 58% increase in chapter 11 filings in 2023.


