New Local Form for Certificate of Service Available On Website

In response to demand, we have created the "Certificate of Service— Instructions & Sample" (<u>Local Form 5-Inst</u>) and <u>Certificate of Service (Local Form 4</u>) documents which are located on the Forms page of our website.

The instructional document contains samples of Certificates of Service attached to a pleading and filed separately after the filing of a document or service of a document pursuant to Court directive. These examples are the preferred method of showing service.

<u>Local Form 4, Certificate of Service</u>, is a fillable form and contains sections for service via Notice of Electronic Filing (NEF), U.S. Mail, Personal delivery or other non-standard delivery options. Please be mindful that facsimile or email service are not routine methods of service in this district and may only be used with the consent of the parties being served and in only exceptional situations (e.g., emergency hearings).

ECF Essentials

New Filing Event for Chapter 13 Cases:

Notice of Debtor's Compliance re Ch 13 Trustee's Motion to Dismiss (Limited Use) (Paperless)

A new filing event for use by Chapter 13 debtor's counsel has been created for counsel to indicate that the debtor has rectified all issues and/or deficiencies defined in the Chapter 13 Trustee's Motion to Dismiss (negative notice).

Upon the docketing of this paperless Notice, the Chapter 13 Trustee will review the case to confirm all issues have been resolved and will withdraw the motion or file an amended motion stating only the outstanding issues and/or deficiencies, as applicable.

This Notice event may only be used on **Motions to Dismiss filed on negative notice** and will not be considered when filed in relation to any other motion to dismiss filed in the case, nor will it cause the cancellation of any hearings associated with other motions to dismiss.

MMM and Chapter 13 Issues

We are in the process of finalizing an administrative order on MMM designed to maintain, to the extent possible, uniformity with the Middle and Southern Districts of Florida. Note that MMM is now available in all cases and for all types of property. We are also working on updating a list of "no look" Chapter 13 attorney fee amounts. McDaniel, II. Please take an opportunity to thank these busy lawyers yourself, and let them know if you would also like to serve on this Committee.

District News

We are pleased to welcome Henry A. Callaway of Hand Arendall, LLC, of Mobile, Alabama, who has been named as the replacement for Judge Margaret Mahoney, ALSB, who is retiring in April of this year (to learn more go to http://www.handarendall.com/attorney_detail.php?attorney=71). Judge William Shulman will be retiring after his replacement is named; the deadline for applications for this position passed on March 6, 2015, so we will soon be welcoming a second new judge to ALSB. We anticipate possible changes in the way our court assigns Pensacola cases; not only Chapter 11 cases but also Chapter 7 and 13 cases, and adversary proceedings. Meanwhile, because of decreased bankruptcy filings in our District as well as nationwide, the Eleventh Circuit has declined to recommend a new judgeship for FLNB.

HELP DESK HINTS... Determining Electronic Recipients in ECF

There are several ways to obtain this information however, you must be logged into CM/ECF before logging into PACER in order to access all of these options.

Bankruptcy > Official Mailing Matrix

We have made a local modification to designate all registered users of the FLNB CM/ECF system (i.e., electronic recipients) with a plus sign behind of their name on the official mailing matrix (e.g., "United States Trustee +"). Review the matrix to see which **parties** will receive a Notice of Electronic Filing (NEF) of your filing. There is no PACER fee associated with the matrix.

Bankruptcy > Electronic & Manual Service Lists

This report will provide the name(s) and email address(es) of all <u>parties</u> who are on the list to receive email notice for the case. You will also be provided a list of <u>parties</u> who must be served manually. There is no PACER fee for this report.

Email receipt of the Notice of Electronic Filing (NEF)

When your user account settings are such that you will receive individual notification of filings in your cases (vs. a single, daily summary of activity), you will receive the actual NEF of each filing. To view or modify your account settings select **Utilities > Maintain My ECF Account > Email Information > Send a notice of each filing.** The NEF will contain a list of the name(s) and email address(es) of all <u>parties</u> who received the NEF, as well as <u>parties</u> who did not receive electronic notification of the filing.

Viewing the "Silver Ball" via Reports > Docket Report

When generating a Docket Report, you have the option to include "Links to Notices of Electronic Filing." Checking the box to include the NEFs will cause a small, silver ball to appear to the left of the docket number hyperlink on the docket report. This silver ball reproduces the Notice of Electronic Filing for the docket entry and will contain the name(s) and email address(es) of all <u>parties</u> who received the NEF, as well as <u>parties</u> who did not receive electronic notification of the filing. **NOTE: The "Links to Notices of Electronic Filing" checkbox option is not available in PACER. You must be logged into CM/ECF prior to logging into PACER to have access to this option. Regular PACER fees apply to the Docket Report but there is no additional charge to view the NEF.**

Please note that these options, with the exception of the Official Mailing Matrix, reflect only <u>parties</u> and do not include general creditors or claimants in a case unless counsel for the creditor has filed a Notice of Appearance in the specific case being queried.

Tips & Tricks

Notice of Returned Mail to Debtor/Debtor's Attorney

The language on this form was changed to direct that the form be filed electronically although filing by U.S. Mail is still an option as this form is also sent to *pro se* debtors. To file the form in CM/ECF use the **"Notice of Change of Address"** filing event. Thank you.



Do Not Forget - May 5, 2015 is Nomination Day

The NCBJ will host the fifth *Next Generation Program* at the annual conference in Miami from September 27-30, 2015. The program is designed to host 40 up-and-coming bankruptcy practitioners with five to 10 years of experience. Nominations for qualified program candidates will be accepted on May 5, 2015.

A candidate should:

- devote at least 50 percent of his/her practice to bankruptcy cases;
- demonstrate legal excellence in the practice of bankruptcy law;
- demonstrate a commitment to the continued educational development of bankruptcy professionals and professional activities that will benefit the public, members of the bar and the court system; and display a serious commitment to principles of civility, ethics and professionalism.

Only one attorney from any single law firm may participate. The cost of attendance at the Annual Meeting must be borne by the participant's law firm, but no additional cost will be incurred to attend the Next Generation judicial roundtable and networking and reunion receptions described below. There will be a charge for the optional reunion dinner. Five scholarships will be available to qualified candidates.

Watch for additional details on how to nominate your candidate and for the special events that will be held exclusively for Next Generation participants, including a judicial roundtable discussion (a unique opportunity to meet with prominent judges and senior attorneys in a small-group setting); a networking reception (a chance to build contacts and relationships as the participant progresses in your firm's practice); and a reception and dinner with NextGen participants from prior years. Florida Northern Bankruptcy Court's Innovative Use of Courtroom Technology

The financial challenges of today's judiciary budget require us to reevaluate spending priorities, implement creative solutions, and promote cost containment. Information Technology (IT) is one tool that can allow courts to achieve this goal. The Northern District of Florida Bankruptcy Court is doing its part to promote cost containment through the implementation of an advanced courtroom technology system.

The geographical area of the Northern District includes the panhandle of Florida south to Gainesville, complete with a time zone change. Currently, the district is allotted one Bankruptcy Judge. Our Chief Bankruptcy Judge, Karen K. Specie, holds court in each of the four divisions. Mileage between the divisional offices is substantial. Travel from her headquarters in Tallahassee to Gainesville, Panama City, and Pensacola equates to 300 miles, 240 miles, and 400 miles round-trip, respectively.

In an effort to assist Judge Specie while helping to control judiciary and case participant travel costs, the Clerk's Office has invested time, funding and training into a professional grade courtroom digital audiovisual (A/V) system. The Court's A/V system, used in combination with the Administrative Office of the United States Courts' National Video Teleconferencing Service (NVTCS), allows Judge Specie to hold a single hearing in multiple divisions simultaneously. For example, Judge Specie may appear live in Tallahassee while attorneys participate via the telephonic CourtCall system and from courtrooms in other divisions by video conference.

In a district such as ours, this technology provides benefits and a degree of flexibility that allows Court needs to be met. Judge Specie determines when and how the system will be used to maintain the delicate balance between face-time and technology that often requires her to travel to the other divisions. She also has the flexibility to address scheduling needs presented by attorneys who have a client base spanning multiple divisions and time zones. According to Paul Neely, Florida Northern Bankruptcy's Chief Deputy Clerk and manager of our IT program, "[Judge Specie] would be hard-pressed to get this monumental task done if she did not have the ability to hold hearings using our video system between all four locations. Simply put, because NVTCS marries all the Northern District of Florida's courthouse locations together into one system, we now can hold court from any location on the fly."

Our IT support system has also received a boost through technology. Systems and Operations Support (SOS) staff monitors streaming courtroom audio feeds from their offices which allows technical issues to be addressed without interrupting a proceeding. Thanks to the work of IT Administrator, Bruce Justham, access to audio feeds by court staff is readily available through our SharePoint intranet site. Mr. Justham was also instrumental in the installation of the Tallahassee courtroom A/V system resulting in additional project cost-savings.

A/V system benefits have also been favorably received by judges from other districts. The Northern District of Florida Bankruptcy Court receives judicial assistance from Alabama Southern Bankruptcy and, for conflict cases, Florida Middle Bankruptcy. Chief Bankruptcy Judge William Shulman (ALSB), Judge Margaret Mahoney (ALSB), and Chief Bankruptcy Judge Karen Jennemann (FLMB) have the option to take advantage of our court-room technology as needed to hold hearings on Florida Northern cases from their respective home court locations.

Overall, the expenditure of resources to see this program to fruition have been repaid in terms of the time and cost savings experienced by judges, case participants, and court staff. We are proud to know that our Tallahassee courtroom is one of the most technologically advanced courtrooms in the country according to an industry expert. We are equally proud to have exemplified the ingenuity of the bankruptcy IT community in their national effort to promote cost containment within the judiciary through effective applications of technology. Our court supports the growth of innovative IT practices and encourages the court community as a whole to invest in IT and its people so that the Judiciary maintains its leading role in the promotion of effective organizational design and technological development.
