4. **Payment options:** Money orders, cashier's check, and non-personal checks drawn from an attorney's trust or operating account (unless the maker is a Chapter 11, Debtor-in-Possession), an account of the trustee appointed to the case for which the payment is remitted, or any United States, state, or local government will be accepted.
